Sl. No.	The school is directed to ensure that:
1	The total number of sections shall be restricted to 25, out of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	Some part of boundary wall is below 6 ft height. The boundary wall should be fully concrete without any gaps/grills/iron mesh/ and of 6 ft height all around the school building. The school should construct proper boundary wall on all sides and submit the compliance through videography on SARAS portal.
3	The school should install fire extinguisher in Physics lab and submit the compliance within 3 months on SARAS portal.
4	The school should remove the curtains which are a fire hazard in Biology lab and submit the compliance through videography within 3 months on SARAS portal.
5	The school should complete the flooring work in the Composite science lab and in other places and submit the compliance through videography within 3 months on SARAS portal.

6	The school should maintain cleanliness and hygiene in the general washrooms and CwSN toilets. The compliance should be submitted on the SARAs portal within 3 months.
7	The CwSN washroom shown on first floor has a step to access the toilet seat which is inconvenient for CwSN students. The school should renovate it so that the flooring inside is even and is easily accessible for CwSN students. The school should submit the compliance through videography within 3 months on SARAS portal.
8	The school shall ensure the mandatory training of its teachers with CoE Panchkula within 3 months and submit the compliance on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
